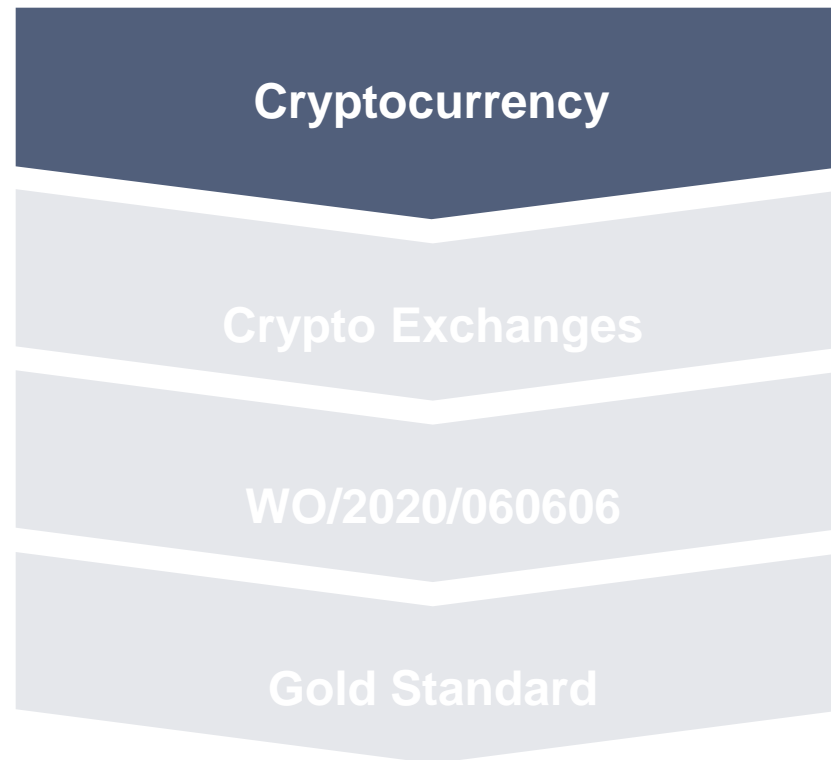

Blockchain



Blockchain is a type of distributed ledger technology with a system of recording information in a way that makes it difficult or impossible to change, hack, or cheat the system.

Proof of Work requires the people who own the computers in the network to solve a complex mathematical problem to be able to add a block to the chain.

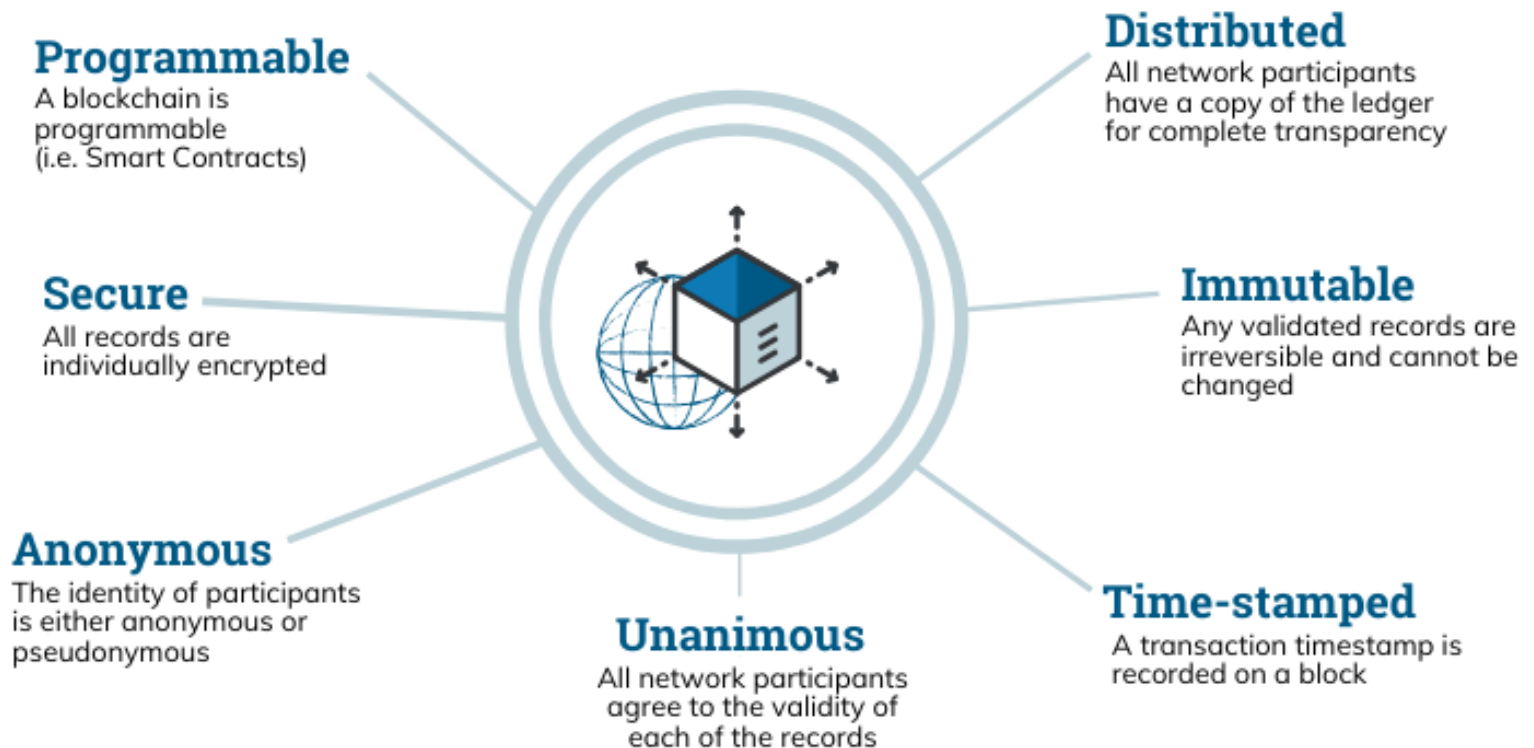
Later blockchain networks have adopted “**Proof of Stake**” validation consensus protocols, where participants must have a stake in the blockchain - usually by owning some of the cryptocurrency - to be in with a chance of selecting, verifying & validating transactions. This saves substantial computing power resources because no mining is required.

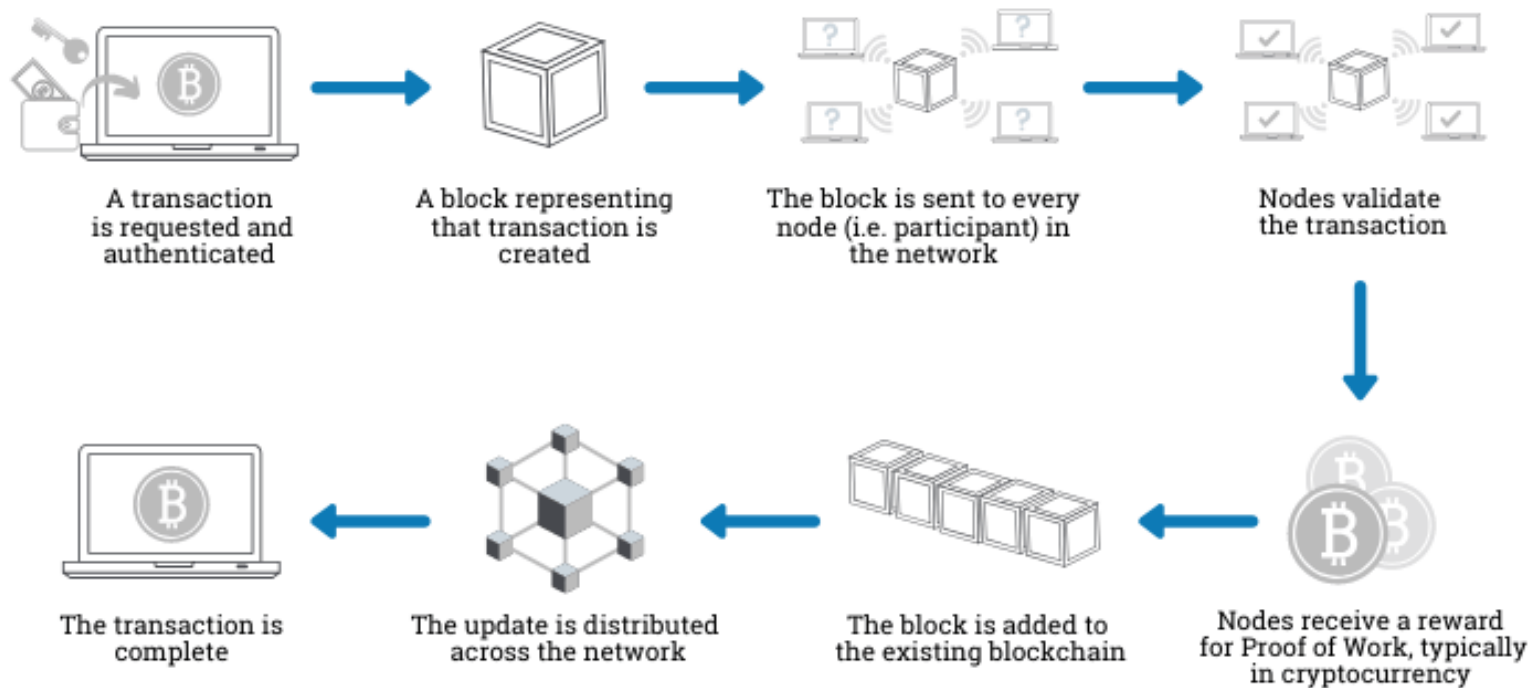

Digital Currencies



Digital currency refers to any means of payment that exists purely in electronic form. **Digital currency** is not tangible like a dollar bill or a coin. It is accounted for and transferred using computers. One well-known form of **digital currency** is the **cryptocurrency**.

Cryptocurrency is an unregulated **digital currency** that is secured by cryptography, typically on a blockchain or similar distributed ledger. **Cryptocurrencies** are usually decentralized, meaning that no single entity has control over transactions or account balances.

Unlike centrally issued digital money, **cryptocurrencies** cannot be recovered if lost or stolen.





Initial Coin Offering (ICO)

An ICO is the cryptocurrency industry's equivalent to an initial public offering (IPO). A company looking to raise money to create a new coin, app, or service launches an ICO as a way to raise funds.

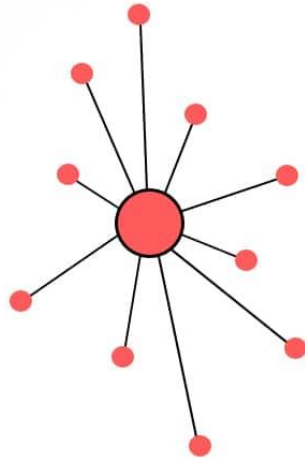
Security Token Offering (STO)

A security token represents an investment contract into an underlying investment asset, such as stocks, bonds, funds and real estate investment trusts (REIT).



The New Networks

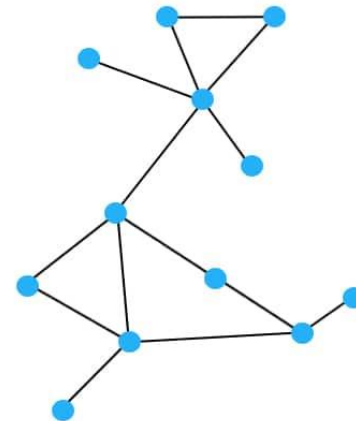
Centralized



Centralized systems have a core authority that **dictates the truth** to the other participants in the network.

Only **privileged users** or institutions can access the history of transactions or confirm new transactions.

Decentralized



Decentralized systems have **no core authority** to dictate the truth to other participants in the network.

Every participant in the network can access the history of transactions or confirm new transactions.



Bitcoin Origins



In late 2008, around the time of the financial crisis, a groundbreaking post appeared on a little-known internet forum written by a mysterious person called **Satoshi Nakamoto**.

Satoshi thought that the banks and governments had too much power that they used for their self-interests. **Satoshi** envisaged a new type of money called **Bitcoin** that wasn't controlled or run by central banks or governments, that you could send anywhere around the world, with no person or institution in charge.

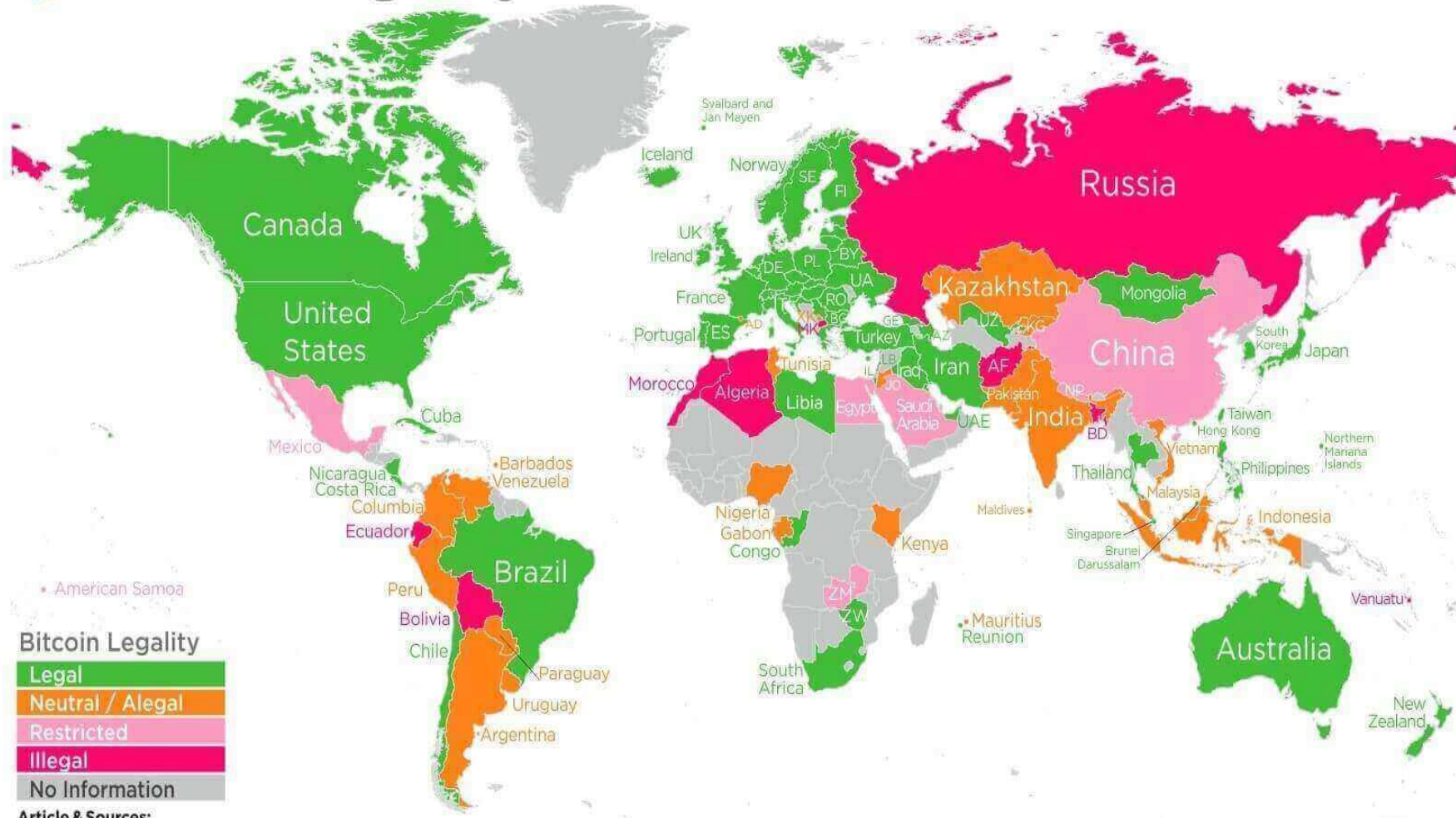
Many believe **Bitcoin** to be the future of money, and the worse the big banks behaved the more popular it became.

Stable Coins



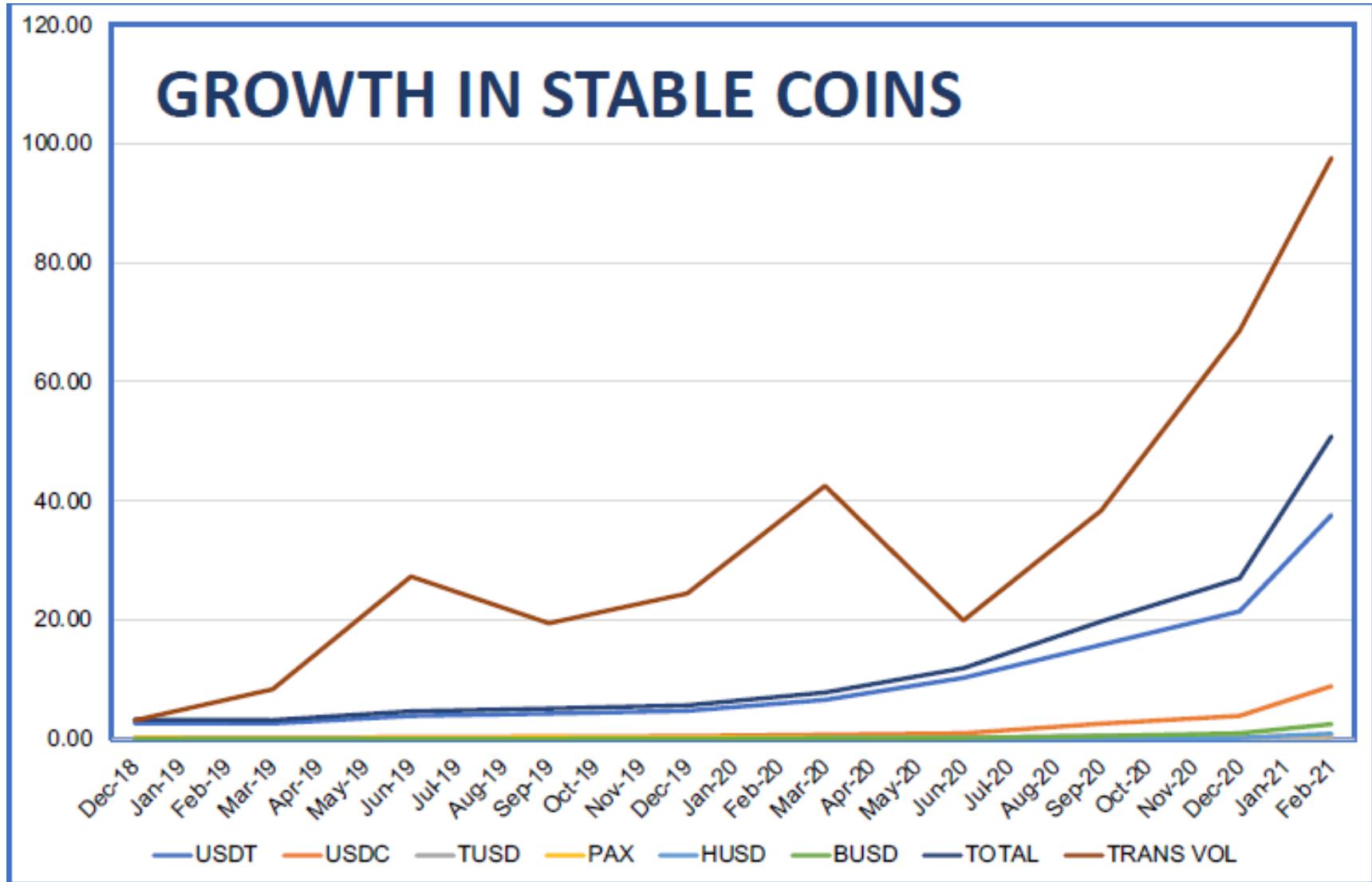
Stable coins are cryptocurrencies that attempt to peg their market value to some external reference, such as a currency like the U.S. dollar or to a commodity's price such as gold.

Stable coins achieve their price stability via collateralization (backing) or through algorithmic mechanisms of buying and selling the reference asset or its derivatives.

Stable coins have gained traction as they attempt to offer the best of both worlds—the instant processing and security or privacy of payments of cryptocurrencies, and the volatility-free stable valuations of fiat currencies.

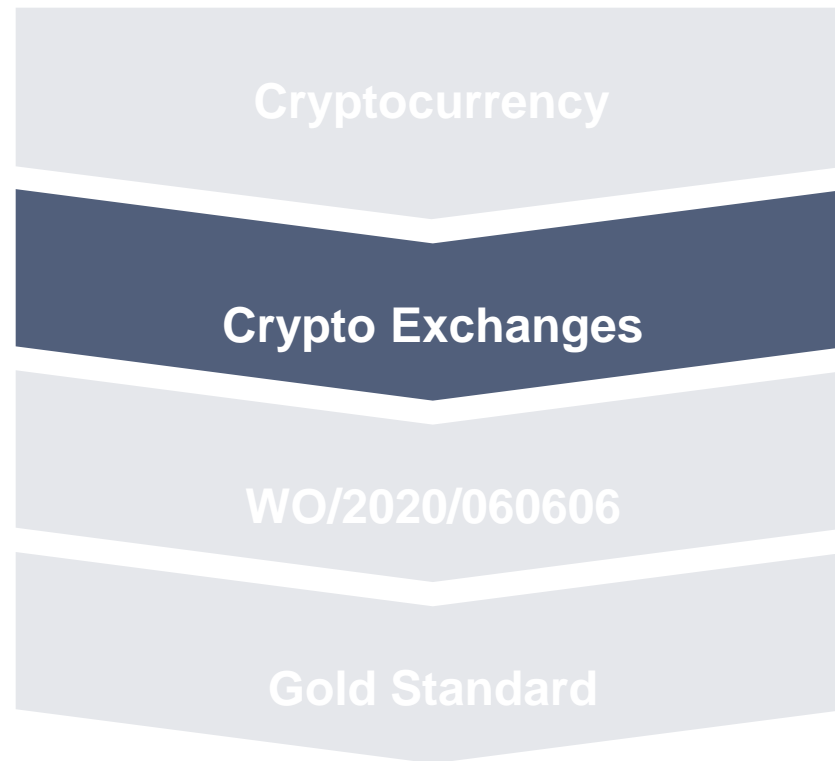


The Rise of Stable Coins

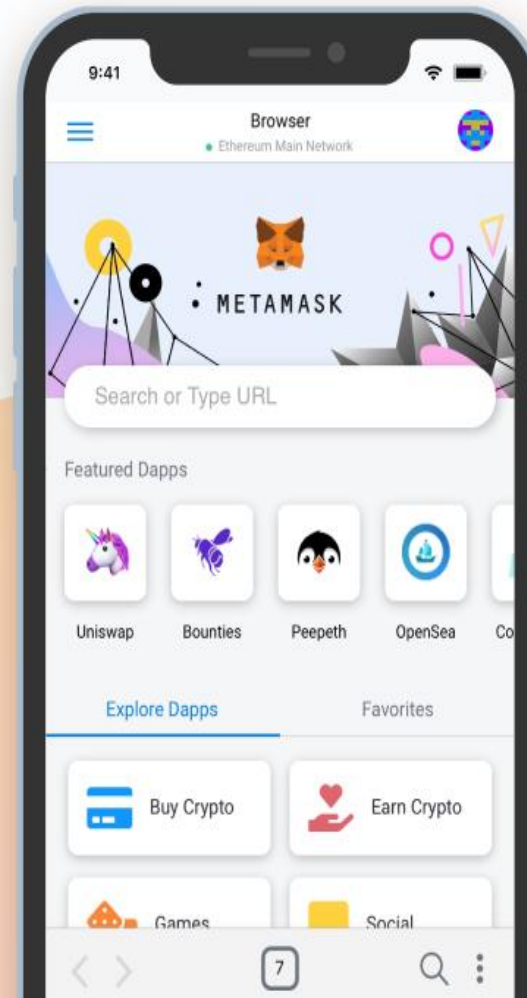

- ❑ **CoinMarketCap** : Provides cryptocurrency market cap rankings, charts, and more. Their website tracks capitalization of various cryptocurrencies by listing prices, available supply, trade volume over last 24 hours, or market capitalizations. The website has historical snapshots, currency converter calculator, crypto glossary, API service, events calendar, and offers a watchlist for users to personalize.
- ❑ **CoinGecko** : Provides 360 degree overview of digital currencies and provides tools for users to fundamentally analyze the market. In addition to tracking price, volume, and market capitalization, CoinGecko tracks community growth, open-source development, major events and on-chain metrics.

Attacks on Binance



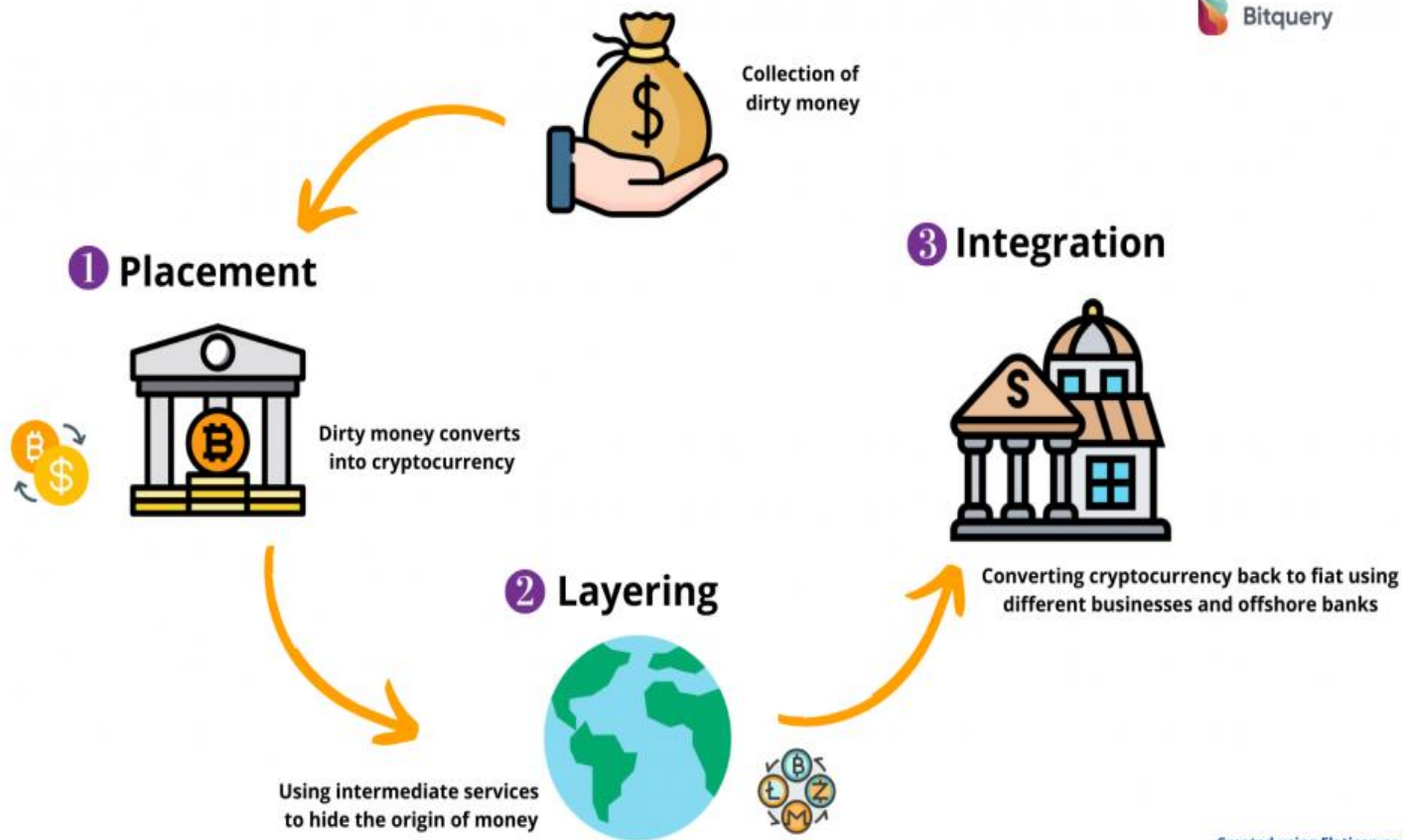
Binance is increasingly coming under fire from regulators. The Cayman Islands Monetary Authority (CIMA) states that Binance is not registered to operate as a crypto exchange from the British overseas territory.

In Japan, the Financial Services Agency (FSA) warned that Binance continues to operate without authorization. A similar notice was issued by UK's Financial Conduct Authority (FCA), in which they announced that Binance is not allowed to engage in regulated activities in the UK.

Malaysia's securities commission said Binance must disable both its website and mobile application 14 days from July 26, immediately cease all media and marketing activities, and restrict Malaysian investors from accessing Binance's group in Telegram.



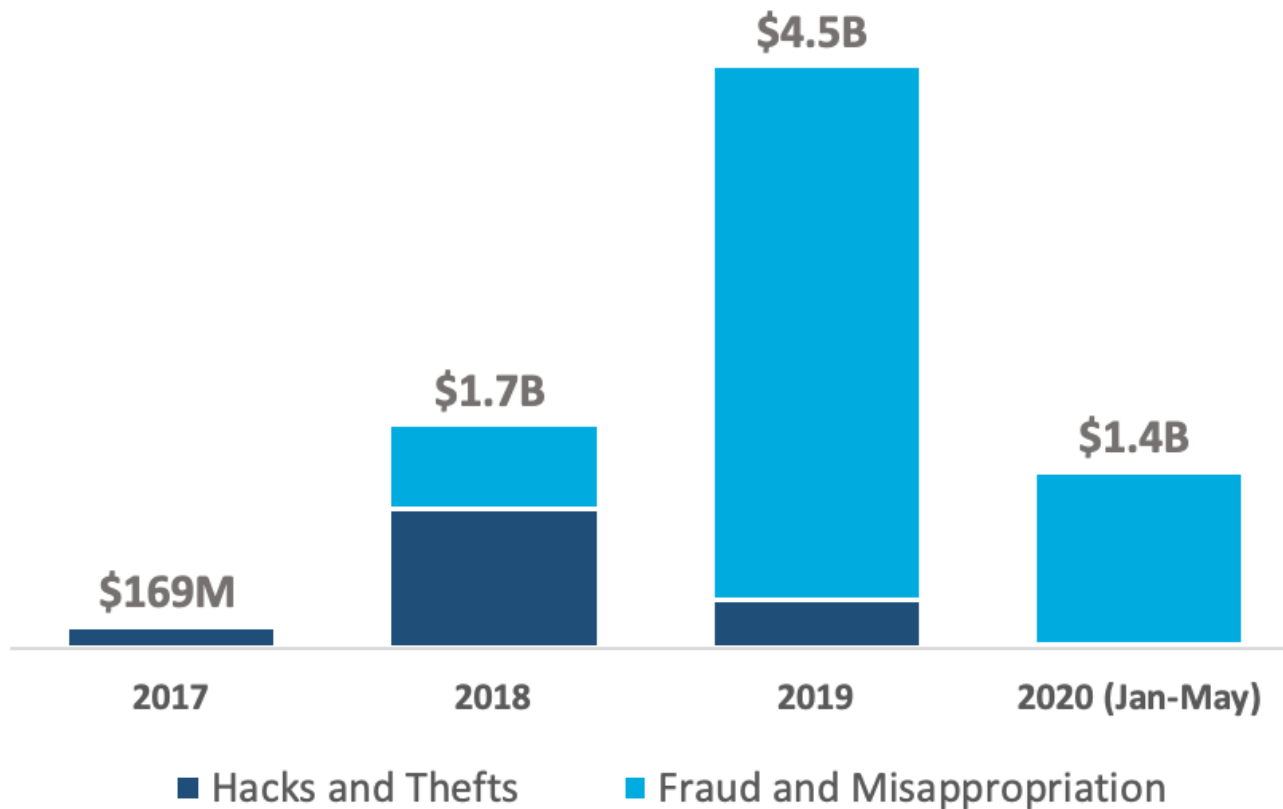

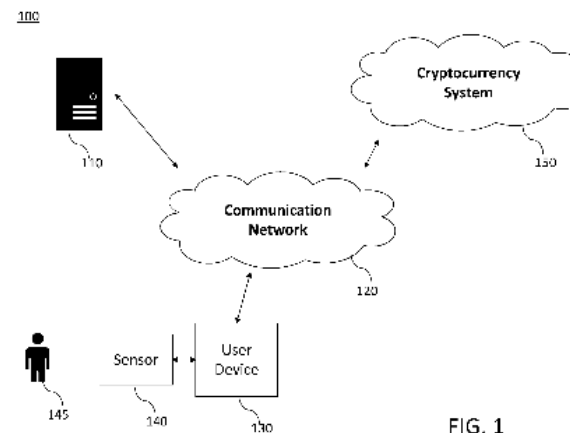

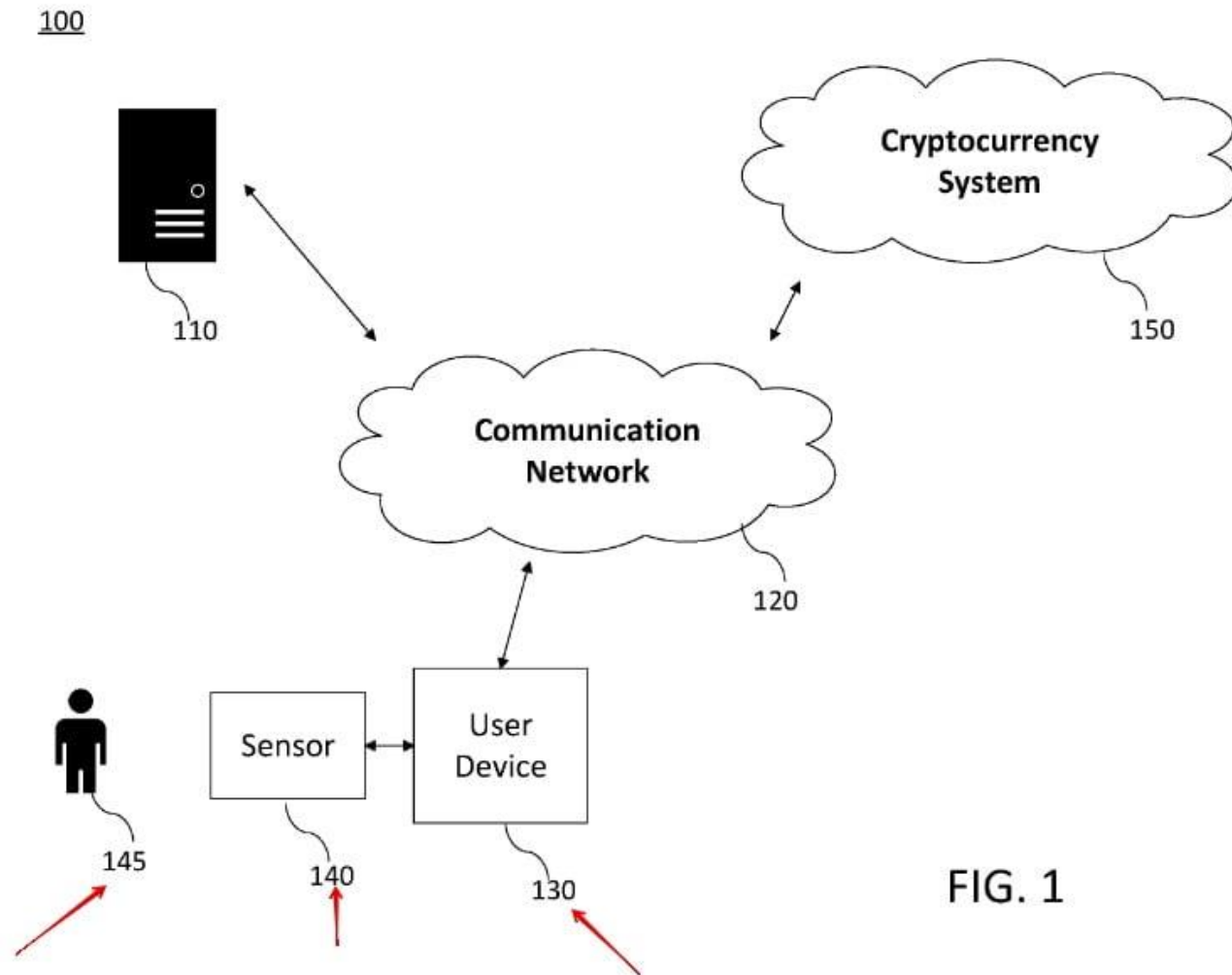

Human body activity associated with a task provided to a user may be used in a mining process of a cryptocurrency system. A server may provide a task to a device of a user which is communicatively coupled to the server. A sensor communicatively coupled to or comprised in the device of the user may sense body activity of the user. Body activity data may be generated based on the sensed body activity of the user. The cryptocurrency system communicatively coupled to the device of the user may verify if the body activity data satisfies one or more conditions set by the cryptocurrency system, and award cryptocurrency to the user whose body activity data is verified.

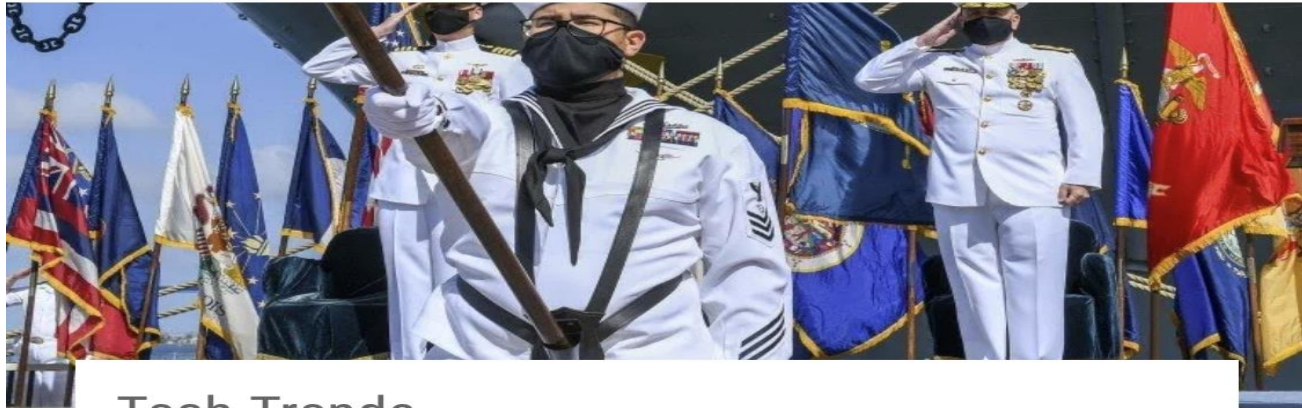

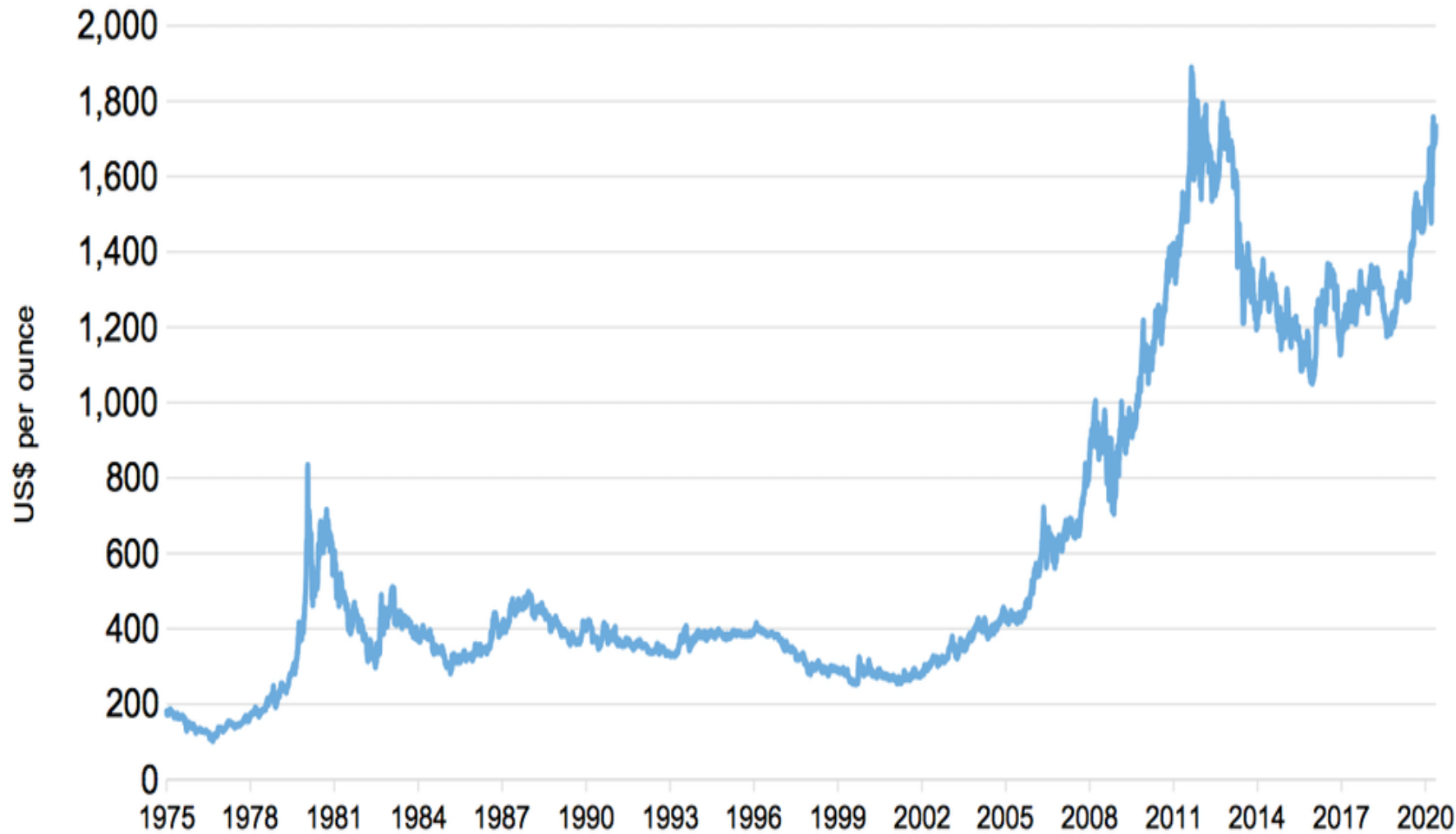

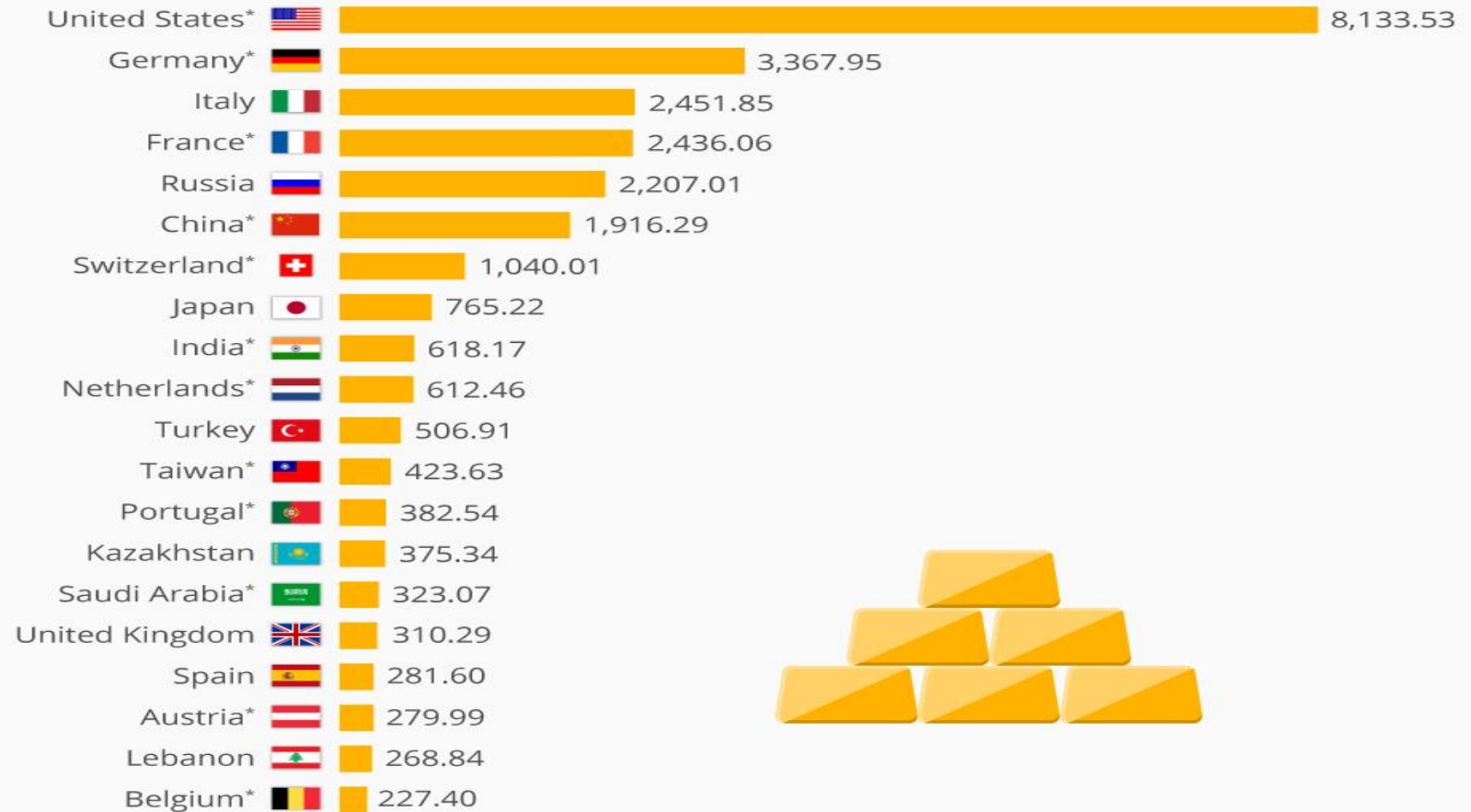

Countries with the largest gold reserves worldwide as of June 2019 (in metric tons)

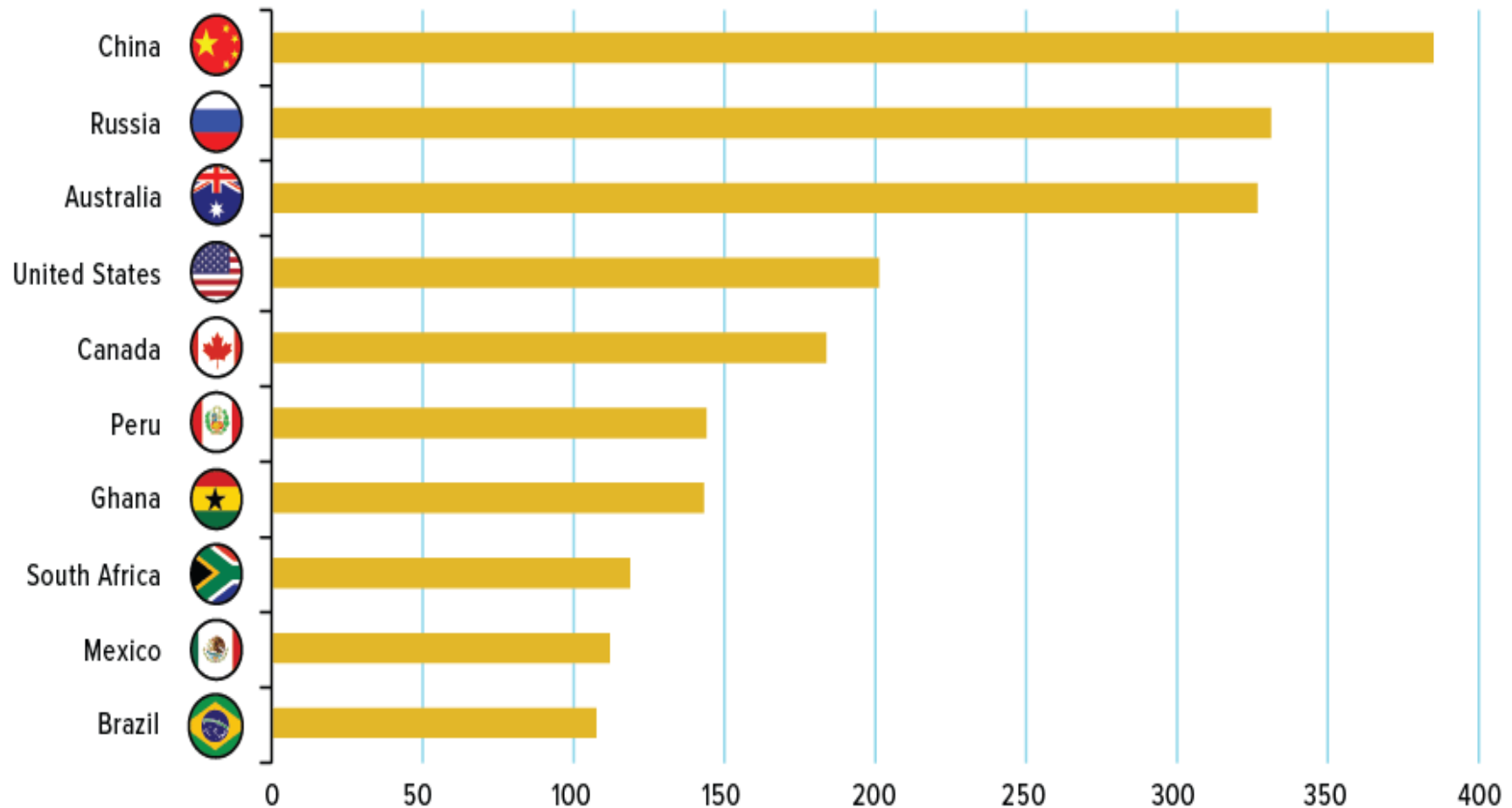


Gold Producing Countries
